Herman Greathouse in Twain: The Conflicting Timelines of Herman Greathouse of Pennsylvania, Maryland and Virginia

A comparison of the conflicting timelines of Herman Greathouse of Philadelphia County, Pennsylvania; Frederick County, Maryland; Frederick, Hampshire, Augusta, West Augusta, Yohogania and Ohio County, Virginia versus Herman Greathouse of Philadelphia and Lancaster County, Pennsylvania; and Baltimore County, Maryland between 1745 and 1796.^{*}

Proof that Herman Greathouse who married Mary Stull and resided in Philadelphia County, Pennsylvania; Frederick County, Maryland; Frederick, Hampshire, Augusta, West Augusta, Yohogania and Ohio County, Virginia, was not the same Herman Greathouse who married Mary [maiden name unknown] and resided in Lancaster County, Pennsylvania and Baltimore County, Maryland between 1745 and 1796.

Problems:

There were two contemporary men by the name of Herman Greathouse who lived in their respective counties of Philadelphia County, PA; Frederick County, MD; Frederick, Hampshire, Yohogania and Ohio County, VA; and Lancaster County, PA; and Baltimore County, MD between 1745 and 1796.

The two contemporary men by the name of Herman Greathouse, both married wives, who were named Mary.

Between 1759 and 1772, Paw Paw, Hampshire County, VA was located 112 miles west of Marriottsville, Baltimore County, MD. This journey would have taken about five days by wagon.

Between 1773 and 1796, Herman's Run, Yohogania or Ohio County, VA was located 263 miles west of Marriottsville, Baltimore County, MD. This journey would have taken about thirteen days by wagon.

Conclusions based on the evidence presented below:

- There were two contemporary men by the name of Herman Greathouse who lived in their respective counties of Philadelphia County, PA; Frederick County, MD; Frederick, Hampshire, Yohogania and Ohio County, VA; and Lancaster County, PA; and Baltimore County, MD between 1745 and 1796.
- The two contemporary men by the name of Herman Greathouse, both married wives, who were named Mary.
- Herman Greathouse of Baltimore County, MD, husband of Mary [maiden name unknown] was related as age about 75 in 1792 by Francis Snowden Esq., Justice of the Peace, Baltimore County, MD. So Herman Greathouse was born about 1717. While in 1786, Herman Greathouse of Baltmore County, MD sold a certain lot or piece of land containing six [6] acres to Christopher Yeakle of Philadelphia County, PA. The text of the deed reads in part, "Whereas Henry Gratehouse late of Lancaster County Yeoman Father of the said Harman Greathouse ... Lawfully Seized ... during his life time ... a Certain Lot or Piece of Land situated in Springfield Township in the county of Mongomery (late the County of Philadelphia) ... Containing 6 acres ... Now this Indenture Witnesseth that the said Herman Gratehouse the

Eldest Son of the said Deceased [Henry Gratehouse] for and in consideration of the Sum of Seven Pounds Seven Shilling and Six Pence in Gold and Silver Coin unto him in Hand well and truly paid by the said Christopher Yeakel ..."

- Johannes Adolph Grothaus, was named in the records of St. Michael's Evangelical Lutheran Church, as a trustee/warden in the founding documents of the church in 1738; as an elder of the church at the First Convention of the Lutheran Ministerium in 1748; and he stood on the side of Rev. Heinrich Melchior Muhlenberg, as an elder representing the church during the 1762 Rapp Suite which was decided in court. Therefore, St. Michael's Evangelical Lutheran Church, Germantown, Philadelphia County, PA was exactly where we should expect to find children of Johann Adolph Grothaus witnessing baptisms and marriages, when they became "of lawful age 21" or an adult, which was required in Lutheran churches at the time.
- Therefore, Herman Greathouse, husband of Mary Stull, both of Philadelphia County, PA; Frederick County, MD; Frederick, Hampshire, Yohogania and Ohio County, VA; was probably the son of Johann Adolph & Anna Amelia Miller Grothaus of Springfield, Philadelphia County, PA. Herman Greathouse of Harmon's Creek, Ohio County, VA was named in three deeds between 1792 and 1796, as having a corner to land of Alexander Wells, William Griffith and Thomas Edgington. In Thomas Edgington's 1796 resurvey of his 935 acre tract, his corner was to Harman Greathouse deceased.
